

Service fees and fee codes for Saskatchewan Workers' Compensation Board psychological health service providers

Primary-level care and assessment services

Use these WCB fee codes and fees to bill for primary-level services provided to WCB customers by psychological health providers. **When the WCB sets a prorated fee, bill using the major portion thereof method.** At least half of the minimum time stated in the code must pass before you bill an additional unit.

Psychological health assessment no-show or short notice cancellation fee ¹	3100	Per 10 minutes (note time unit change effective Jul. 1, 2025) to a maximum of 15 hours (90 units)	\$26.18
Mileage to/from jobsite/home ³	911	Per kilometre	Per kilometre

Notes:

- ¹ Psychological health service providers may bill 60 per cent of the expected billing when the worker does not attend the assessment or when the WCB provides less than a 72-hour cancellation notice.
- ² Billable where the WCB requests a review of several consultations and a summary of the issues and treatment from the current or past involvement.
- ³ The WCB pays the Public Service Commission (PSC) mileage rate for out-of-town travel (the insurer must authorize the travel before the cost is incurred).
