Service fees and fee codes for WCB psychological health service providers

Primary-level care and assessment services

These WCB fee codes and fees are to be used to bill for primary-level services provided to WCB customers by psychological health providers. Where a prorated fee is indicated, the provider will bill using the major portion thereof method. At least half of the minimum time stated in the code must have elapsed for the additional unit to be billed.
